### COURT FEES AND ENDORSED COSTS - UPDATED

The fees payable, and endorsed costs claimable, in Supreme Court proceedings from 1 July 2024 are attached.

The fees prescribed in various rules and regulations applicable to Supreme Court proceedings are set by reference to “fee units” under the *Fee Units Act 1997*. The value of a fee unit has increased to \$1.87 from 1 July 2024.

Attached is a Table of Fees prescribed under the:

- *Supreme Court Rules 2000, Schedules 1 and 3*
- *Legal Profession Regulations 2018*
- *Civil Process (Table of Fees for Execution) Rules 1991*

The Appeal Costs Fund fee payable on filing a writ commencing an action in the Supreme Court will also increase to \$56.10, in line with the *Fee Units Act 1997*.
